

DEFINING AND SCALING UP COMMUNITY-LED HIV RESPONSES

Increased recognition and support for community-led HIV responses

Stronger capacity of community-led organizations

NEW FRAMEWORK AND METHODOLOGY for monitoring progress towards the 30–80–60 global HIV targets focused on scaling up community-led HIV responses

Over 70 countries supported to expand **COMMUNITY-LED HIV RESPONSES**, including advocacy, service delivery and monitoring

Oral **PRE-EXPOSURE PROPHYLAXIS** provision expanded and delivered by communities in Asia and the Pacific



Networks of women living with HIV in over 10 countries and youth-led organizations in over 12 countries empowered through **CAPACITY-BUILDING AND PEER LEARNING**

COMMUNITY-LED MONITORING AND RESEARCH FOR BETTER PROGRAMMES TO CLOSE GAPS

Expansion, increased use and widely shared knowledge of community-led monitoring

Community-led research and advocacy to tackle stigma and gender inequalities

GENDER ASSESSMENTS in 12 countries identified social, legal and service gaps for women living with or affected by HIV

People living with HIV **STIGMA INDEX** reports finalized in 10 countries, and used to inform policy change, programmes or resource mobilization in over 30 countries

Supported **COMMUNITY-LED MONITORING** in 65 countries, **INCLUDING COUNTRY ACTION PLANS** in 30 countries in Asia and the Pacific and west and central Africa

PROMOTING THE VOICE AND LEADERSHIP OF COMMUNITIES FOR A PEOPLE-CENTRED AND RIGHTS-BASED HIV RESPONSE

Empowered people living with HIV, women and girls, young people and people from key populations, for meaningful engagement including dialogue with governments and other actors

Advocated for more protective HIV-related national laws and policies



Promotion of **RIGHTS OF LGBTQI+ PEOPLE** in over 60 countries, improving inclusive access to HIV services

Rise and Decriminalize Movement uniting 5 community-led regional networks advocated for the **RIGHTS OF PEOPLE FROM KEY AND VULNERABLE POPULATIONS** in eastern Europe and central Asia

Supported over 20 countries for more **GENDER-RESPONSIVE HIV SERVICES** through advocacy and promotion of meaningful engagement of women and men

Organizations led by people living with HIV and people from key populations in 21 countries received funding to **COUNTER DISCRIMINATORY AND HIV-RELATED CRIMINALIZATION LAWS**, policies and practices

INVESTING IN COMMUNITIES FOR IMPACT

Guidance and data on resource tracking, costing and sustainable financing

Promoted community leadership to optimize resource allocation

SYSTEMATIC REVIEW of the cost of community-led HIV responses available on [UNAIDS Financial dashboard](#)

Promoted **SOCIAL CONTRACTING** to sustain community-led responses

Costing guidance available as part of **HIV SUSTAINABILITY ROADMAPS** and 16 community-led organizations trained to conduct cost analyses of HIV interventions

KEY POPULATION INNOVATION FUND established under the 2gether 4 SRHR programme, with allocations and implementation modalities guided by people from key populations
